### HIGHLINE Instagram Competition Terms and Conditions

- 2. Information on how to enter, mechanics of entry and prizes form part of these Conditions of Entry.
- 3. Entry into the promotion is deemed acceptance of these Conditions of Entry. Entry is through Instagram only.
- 4. The Competition is only open to Eligible Entrants. An "Eligible Entrant" is an individual who, at the time of entry:
  - 1. Is a resident of Australia aged 18 years or older
